You may buy and sell Class EUR A Retail Shares (this "Class") on each business day (Monday to Friday other than public and bank holidays in Malta) subject to certain cut off times.

# Currency:

The Class in the Sub-Fund is denominated in EUR.

The Sub-Fund is generally suitable for investors willing to hold their investment for a minimum period of five years.

## Investment Policy:

The Investment Manager ("We") may invest in a diversified portfolio of listed and/or unlisted corporate and/or government bonds and/or equity securities which will generally be of largeto-mid-cap companies having no particular duration. Such exposure can be achieved both directly and indirectly. Investments may be made in investment grade, sub-investment grade and unrated securities. The Sub-Fund may be biased towards companies in Europe and North America and to the financial sector.

We may also invest in convertible bonds, in warrant-linked bonds, participation and dividend right certificates, perpetual bonds and money market instrument and term deposits. Furthermore, the Sub-Fund may directly or indirectly invest in credit related securities such as asset back securities, subordinated debt, and credit default swaps.

For temporary or defensive purposes, we may hold short-term fixed income instruments, money market funds and cash and cash equivalents. Additionally, the Sub-Fund may invest in exchange traded funds and other UCITS compliant collective investment schemes to fulfil its investment goals. The Sub-Fund is not expected to invest in collective investment schemes managed by the Investment Manager. The Sub-Fund is being actively managed.

# What happens if AQA Capital Limited is unable to pay out?
